## 1 Summary

- 1.1 The purpose of this paper is to seek Procurement Authority for the extension of the Track Labour Framework, which provides external track labour resources required to supplement London Underground's direct labour. The extension is critical to ensure continuity of supply to support safety critical maintenance, enhancements and renewals across the network.
- 1.2 A paper is included on Part 2 of the agenda, which contains supplementary information. The information is exempt by virtue of paragraph 3 of Schedule 12A of the Local Government Act 1972, in that it contains information relating to the business affairs of TfL. Any discussion of that exempt information must take place after the press and public have been excluded from this meeting.

#### 2 Recommendation

- 2.1 The Committee is asked to note the paper and the exempt supplementary information on Part 2 of the agenda and:
  - 1 approve the extension of the framework to March 2025;
  - 2 approve Procurement Authority for £588.75m for the period to March 2024; and
  - 3 note a further request will follow for the financial year 2024/25.

## 3 Background

3.1 London Underground has a continuing requirement to supplement its Direct Labour Organisation (DLO) with external, skilled labour, which is deployed across the network to support safety critical maintenance, enhancements and renewals of Track assets across the network.

- 3.2 The supply of labour from suppliers is contracted on a pan-TfL basis to enable other areas of the business the ability to call off from the framework.
- 3.3 The original Track Labour Framework was let via a competitive tender process and awarded to five suppliers being Morson Human Resources Limited; Cleshar Contract Services Limited; 1st in rail Limited; Trackwork Limited and McGinley Support Services (Infrastructure) Limited. It was let on a pan-TfL basis, which enables other areas of TfL (such as RFLI, Capital Projects, DLR, Trams) to utilise should they need Track Labour resource.
- 3.4 Authority is requested to extend this framework until March 2025, as part of the approach to transition to new Track Works and Resources arrangements. TfL is consolidating its Track related services including labour. The approach considers requirements from across all TfL modes, maximising our opportunity with the external market. This provides the time to complete the strategy, tender and award of the new framework contracts.

### 4 Financial implications

- 4.1 The requested Procurement Authority is £588.75m. This request covers the period to March 2024.
- 4.2 Financial Authority for the provision of Track Labour in 2023/24 was granted by the Board on 29 March 2023 as part of the 2023/24 Budget.
- 4.3 As TfL's funding settlement with Government expires in March 2024, it is not possible to develop the programme of work for 2024/25 or have sufficient confidence in the 2024/25 Budget. Therefore, a later request for procurement authority for 2024/25 will follow after funding discussions with Government have concluded.
