HEALTH & SAFETY

Zero Significant Incidents occurred during P05.

Although the LTC AFR increased by 0.01 this period (due to the calculation method) there has not been a significant injury reported for five consecutive periods.

The total hours worked during P05 was 527k a reduction of 22k from the previous period. Period hours continue to reduce, this is expected as the construction profile of the programme changes.


Following post-handover procedure compliance issues, the work done to confirm ROGS arrangements has resulted in a significant improvement following those early fail safe incidents.


The HSPI score decreased to 2.79, both Paddington and Whitechapel achieved SC3ROGS this period. Five contracts continue to the report HSPI.

Performance – Incidents




Significant Incidents AFRs






Golden Rule Analysis P03 21-22 - P05 21-22




There has been a decrease in the number of breaches of GR4 Follow Work Area Rules, however, there has been an increase of incidents being reported as N/A.

Programme Injury Trends




Interventions - Covid-19 Observations

Periodic reporting confirms the trend with the lowest number of incidents reported by period to date, current reporting levels whilst not confirmed indicate this trend is continuing.


Accident Frequency Rate / Lost Time Injuries / Fatality Weighted Index & RIDDOR



RFLI weekly reporting chart identifies improvements in variation in reporting, this is as expected during Trials. Periodic data indicates an overall reduction in the number and severity of reported incidents

Assessment Body: (AsBo)

- Last week AR514 Organisational Arrangements for Safety was issued back to RfLI at Rev 2.0 with 1 OBS remaining to be resolved. AR559 Assessment of the Rule Book issues at Rev 2.0 with good progress having been made in close out.
